Why do we have Contests?

To provide contest experience and to recognize our best speakers As a learning experience for all

Public relations opportunities: Invite guests to your contests!

A Contest should be:

Well-planned & well-organized

Fair: Consistent, identical treatment
for all Contestants, as much as is possible

Fun!

Which Contests are held when?

Every Spring: International Speech plus one other contest

Every Fall: Two other contests

Other contests: Evaluations; Table Topics; Humorous Speech; Tall Tales

D50 tradition: Humorous every Fall, plus one other contest

Ineligible to compete in any contest:

International Officers, Directors, and Candidates for those offices

District Officers (Top Seven, Division Governors, Area Governors) *Note: Assistants CAN compete*

Immediate Past District Governor

Announced Candidates for District Offices

Anyone presenting an educational session at the Conference

Contest judges (until they are no longer competing)

Past World Champions cannot compete in International Speech

Evaluation rules & procedures

Target Speaker – preferably unknown to all contestants, presenting an early CC speech, and NOT an accomplished speaker

All contestants evaluate same speaker

Any member in good standing of a club in good standing throughout the contest season is eligible (unless on ineligible list)

Table Topics rules & procedures

One question for all contestants

Any member in good standing of a club in good standing throughout the contest season is eligible (unless on ineligible list)

Humorous Speech rules & procedures

Substantially original 5-7-minute humorous story

NOT one-liners or stand-up routine, must have opening, body, conclusion

Any member in good standing of a club in good standing throughout the contest season is eligible (unless on ineligible list)

Tall Tales rules & procedures

Substantially original 3-5-minute exaggerated humorous story

Should be highly improbable, with a theme or plot

Any member in good standing of a club in good standing throughout the contest season is eligible (unless on ineligible list)

International Speech rules & procedures

Substantially original 5-7-minute speech

Substantially original: all quotes must be attributed; all sources credited

Eligibility for International Speech:

Member in good standing of a club in good standing throughout the contest season

Must have completed at least six Competent Communicator Manual speeches prior to club contest

OR be a charter member of a club that has chartered since July 1 of this Toastmasters year

Process of International Contest

Semi-finals and finals will be held at the International Conference

Toastmasters International pays travel expenses for District contest winners

Up to and including the semi-final contest, contests can compete with same speech, but are not required to do so

All contestants must present an entirely new and different speech for International Finals than given at any International contest since Jan. 1 of that year

Protests at contests:

On eligibility or originality only
Only Judges & Contestants can protest
Must be brought to the Chief Judge
before winners are announced

When are the contests?

Check District Calendar for exact dates!

Club Contests: ≈ July to early Sept and Jan to Feb/early March

Area Contests: ≈ Sept/Oct and March/April

Division Contests: ≈ October and April

District Conferences/Contests:

Friday & Saturday inNovember and in May

International Convention (International Speech Contest only): August

Contestant preparation:

Are you eligible?

You can compete in any club contest, but ONLY ONE AREA CONTEST for each contest

Attend Judges' training; review the Judges' ballots

Attend contests – listen & learn!

Contest Chair

The person who puts it all together (Competent Leader Manual Project)

Contest Chair Resources are on the D50 web site

Contest Checklist makes it so much easier!

Contest Script should be reviewed with your Contest Master

Contest Master

Toastmaster of the Contest, keeps it fair, fun, and on time

Contest Master Resources are on the D50 web site

Contest Master How-To really helps

Contest Script should be followed!

Contest Chief Judge & Judges

Judges & Chief Judges have received training through the District

District Chief Judge appoints Contest Chief Judges at least two weeks before contest date

Contest Chief Judges find Contest Judges

Current contestants cannot serve as a judge at the same level they are competing

International Speech rules require SIX judges at Area Contests, EIGHT at Division & District

Contest Helpers

Great way to help your Area/Division/District

Fun and educational experience

Competent Leader Manual Project

Sergeants at Arms (1 per door plus extra for Evaluation & Table Topics contests)

Timers (2)

Ballot Counters (3 for International; 2 for other contests)
